GENERAL LIABILITY RELEASE

Since the sport of badminton may be considered dangerous, we require tournament participants to assume all risks by signing this agreement.

In consideration of being permitted to participate in the tournament, and/or to use the facilities located on the premises of the club, the undersigned for himself/herself, the parent or guardian, if a minor, and personal representatives, assigns, heirs and next of kin, or any of them:

1. Hereby releases, waives, discharges and covenants NOT TO SUE, MBBC or the their respective officers and members (collectively, the "Releasees"), from any and all liability, loss or damage, and any other claims or demands, on account of injury to, or death of, the Undersigned or damage to the property of the Undersigned, whether by the negligence of Releasees or otherwise while the Undersigned is on club premises or resulting from the Undersigned having been on club premises;
2. Hereby Agrees to Indemnify and Hold Harmless the Releasees from any and all loss, liability, damage or cost they may incur do to the presence of the Undersigned in or about the Club premises and whether caused by the negligence to the Releasees or otherwise; and
3. Hereby grants to MBBC, their respective licensees and contractees including, but not limited to: photographers, television and motion picture companies, their respective affiliates and subsidiaries, full television and motion picture rights including authority to film or videotape me during matches, narratives, personal interviews, or comment thereon for any and all commercial, news or other purposes together with the right to transfer or grant their rights to others, all without remuneration or compensation to the Undersigned whatsoever.

The Undersigned expressly agrees that the aforementioned Release, Waiver and Indemnity is intended to be as broad and inclusive as is permitted by laws of the State of California and if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

The Undersigned represents and warrants the following statements are true and correct and understands that the Releasees have relied on them in entering into the aforementioned Release, Waiver and Indemnity and in permitting the Undersigned to participate in the tournament and/or to use the facilities located on the premises of the club.

1. No oral representative, statements or inducements apart from the forgoing have been made
2. The undersigned represents and warrants that he is fully aware of the risks and hazards inherent in entering upon said premises or in participating in any event held in or upon said premises and hereby voluntarily elects to enter said premises knowing the present condition and knowing that said condition may become more hazardous and dangerous during the time that the undersigned or either of them are upon said premises. The undersigned acknowledges that he voluntarily assume all risks of loss, damage or injury that may be sustained by him, or any of them, any damage to any property of the undersigned, or any of them while in or upon said premises.
3. I understand that I am responsible for any all medical costs not covered by insurance.
