In consideration of being permitted to participate in the tournament, and/or to use the facilities located on the premises of the club, the undersigned for himself/herself, the parent or guardian, if a minor, and personal representatives, assigns, heirs and next of kin, or any of them:

- 1. Hereby <u>releases</u>, <u>waives</u>, <u>discharges</u> and <u>covenants NOT TO SUE</u>, MBBC or the their respective officers and members (collectively, the "<u>Releasees</u>"), from any and all liability, loss or damage, and any other claims or demands, on account of injury to, or death of, the <u>Undersigned</u> or damage to the property of the <u>Undersigned</u>, whether by the negligence of <u>Releasees</u> or otherwise while the <u>Undersigned</u> is on club premises or resulting from the <u>Undersigned</u> having been on club premises;
- 2. Hereby <u>Agrees to Indemnify and Hold Harmless the Releasees</u> from any and all loss, liability, damage or cost they may incur do to the presence of the <u>Undersigned</u> in or about the Club premises and whether caused by the negligence to the Releasees or otherwise; and
- 3. - 2. The undersigned represents and warrants that he is fully aware of the risks and hazards inherent in entering upon said premises or in participating in any event held in or upon said premises and hereby voluntarily elects to enter said premises knowing the present condition and knowing that said condition may become more hazardous and dangerous during the time that the undersigned or either of them are upon said premises.
